ENCROACHMENT PERMIT REQUIREMENTS & INSPECTIONS



REQUIREMENTS

1. Encroachment Permit Requiring Inspections: Fee \$211 (Surface); \$462 (Subsurface)
Encroachment Permit Not Requiring Inspections: Fee \$65
2. Security Bond (See dollar amounts specified below)
3. USA Number
4. Start and End State of Project (This may be updated at a later date if necessary)
5. Proof of Liability Insurance in the amount of \$1,000,000 naming the City of Pismo Beach as additionally insured with endorsement sheet attached.
6. State Contractors License Number and Expiration Date.
Contractors may only perform work in which their license specializes
General (A: Any Work); Concrete (C-8); Earthwork and Paving (C-12);
Parking and Highway Improvement (C-32); Pipeline (C-34)
7. A Business License with the City of Pismo Beach.
8. Traffic Control Plan/Pedestrian Control Plan.
9. Signature of Applicant or Contractor stating that they have read "The Permit" statement under the general provisions and understand the permit requirements.

24 Hour Advance Notice for all Inspections (805) 773-4656

ALL WORK MUST CONFORM TO CITY STANDARD DRAWINGS – Ask for a copy today!

- Notification once traffic control is set up
- Prior to placement of dumpster/storage container in street
- Upon removal of dumpster/storage container in street
- Prior to backfill in trench
- Prior to Water Main connection
- Prior to Sewer Man connection
- Prior to Asphalt/Concrete pour (95% compaction test or 2 sack slurry report due at this time)
- Prior to Concrete pour (95% compaction test due at this time; rebar set)
- Prior to completion of work for Final Inspection
- 30 after Final Inspection for Bond Release Inspection

SECURITY DEPOSIT BONDS REQUIRED*

All bonds subject to release 30 days after final inspection

(Contractor/Owner responsible for calling **(805)773-4656** for a bond release inspection)

Minor Encroachment Permits

Minimum Bond = \$500.00

Surface Encroachment Permits

Minor Sidewalk = \$1,000 (<20')

Major Sidewalk = \$1,500 (>20')

Unimproved City Right-of-Way = \$1,000

Driveway Approach (<16') = \$1,500

Drive Approach (>16') = \$1,500 + \$50 / per foot over 16'

Subsurface Encroachment Permits

Water (up to 2 inches) or Sewer Lateral (up to 4 inches) = \$2,500

Water Main (over 2 inches) or Sewer Main (over 4 inches) = \$5,000.00

Street Crane = \$1,000.00 minimum
